Should the clan be prevented from attending due to any of the foregoing reasons, including any serious family illness, unforeseen personal illness to the owner and/or any assistants, transportation equipment failure? OCHA, Festival Committee will consider a partial refund if the following conditions are met

1. OCHA vendor/clan coordinator is notified in writing of the reason for the cancellation no later than June 1, 2008.
2. A request for refund is made to the OCHA Festival committee in writing.

The OCHA, Festival Committee shall meet to consider the request with the understanding that any refund be at the sole discretion of the OCHA, Festival Committee and shall not exceed 50% of the total value of fees received from the vendor.

This contract may not be canceled or modified except by mutual consent in writing by the OCHA, Festival Committee and your the clan regent.
